EDA in Wyoming:


Since 2010, EDA has invested in **47 projects across Wyoming** totaling nearly **\$35 million**. These projects include:

EDA Coal Communities Investments in Wyoming:





Funds the hiring of an Impact Manager to conduct study and implement strategies to assist this coal-impacted region in identifying new markets for existing resources and attract private investment to diversity local economy.



Campbell County Ec. Dev. Corporation, Wyoming Innovation Center: \$1,460,877

Funds development of a business and research hub to develop carbon-based products and advance coal-related technologies from University of Wyoming School of Energy Resources from the laboratory to commercialization. Expected outcomes of regional job creation and economic development.



EDA Coal Communities Investments in Wyoming:



Sheridan Economic & Educational Development Authority (SEEDA), Manufacturing Operations Expansion:

\$2,558,559

Funds construction of 35,000 sq/ft. manufacturing facility in Sheridan High-Tech Business Park for an existing company to expand operations, hire for 50 additional manufacturing jobs, and create new opportunities for displaced coal economy workers.







Northern Wyoming Community College District, Capacity Expansion: \$2,856,829



Funds equipment, supplies, and training materials to expand facilities in Sheridan and Gillette to train machinists, welders, mechanics, and construction trades for high-skill, high-demand careers using latest technology.
